Thank you for correspondence and interest in this project. Retool Gaithersburg does not propose rezoning any properties in the City. Instead, this project is an comprehensive review and update to the City's zoning code with the overall goal of modernizing the Code to better accommodate and implement the City's visions and goals. As such, the property located at 429 E. Diamond Avenue will remain zoned CBD.

We are proposing changes to special exceptions in the CBD zone and I would recommend reviewing the chart located on page 53 of the draft document. The draft includes the following uses as a special exception in the CBD zone:

Automobile Repair and Service establishments (only allowed outside of the Olde Towne Special District)

Light industrial

Care homes

Boardinghouse

Bed and breakfast

Large family day care (accessory use only. Prohibited in all multifamily attached, triplex, quadplex, and all live/work dwellings)

Small family day care (accessory use only. By-right in all single-family detached, duplex, townhouse, and stacked dwellings. Special exception in all multifamily attached, triplex, quadplex dwellings. Prohibited in all live/word dwellings)

Retail store with gas

Telecommunication facilities

Any fee schedule changes related to Retool Gaithersburg are still being reviewed by City Staff.
